### A. Burnables (① Burnable Garbage)

- Fully drain/remove liquid (water, etc.) from raw waste. The City also provides subsidies for purchasing raw garbage disposal units and composting containers.
- Pruned branches from garden trees <u>can</u> be disposed under this category by cutting it into pieces within a length of 70 cm and a diameter of 3 cm. A subsidy is also available for the purchase of twig grinders.
- Thick plastics with more than 3 cm of thickness, are to be disposed under "Non-Burnable Metal wares", as these will be crushed and burned at the processing plant.
- Open-air burning is prohibited by law (with some exceptions).

#### B. Recyclables (2)Cans (Food & Drink)/3)Glass Bottles (Food & Drink)/4)PET Bottles/5)Food Tray & Styrofoam)

- PET bottles, Food Trays & Styrofoam are <u>not</u> collected via Garbage Bags.
- Collection nets are prepared at designated locations and on designated collection days in each district. Please dispose through these collection nets.
- Wash PET bottles with water (remove the caps; caps fall under "Burnable Garbage", peel off the label as well) and dispose without crushing.
- Food trays with coated surfaces (such as cup noodle containers) cannot be disposed under this category. Please dispose under "Burnable Garbage".
- If dirt and stains cannot be removed from the items, dispose as "Burnable Garbage".

#### C. Non-Burnables (⑥ Metals (except Food & Drink Cans) / ⑦ Glass (except Food & Drink Bottles)

- Describe the waste by encircling either "Food / Drink Cans" or "Food / Drink Bottles" on the Recycled Goods Trash Bag before disposing of them. If you are disposing both "Food / Drink Cans" and "Food / Drink Bottles", put each in separate Recycled Goods Trash Bags (you will need two trash bags).
- Completely empty out spray cans and gas cylinders (cartridge-type) before disposing.
- Remove any remaining gas (using a gas vent cap, etc.) in a place far from open flames.
- Completely empty out cans and bottles that contained oil, paint, etc. before disposing.
- Dispose thick plastics with more than 3 cm of thickness as "Non-Burnable Metal wares".
- Wrap shattered glass pieces with newspaper, etc. before disposal. (Do not put inside cardboard boxes, etc.)
- Dispose Fluorescent Lamps, Thermometers, etc. as "Special Garbage".

#### D. Bulky Garbage (③Items not exceeding 150 × 80 × 60cm or Specified Items / ④Items exceeding 150 × 80 × 60cm)

- Attach a ¥500 Bulky Garbage Sticker per item of up to 150x80x60 cm as well as for items larger than 150cm but within 230cm (ski boards, bicycles, galvanized iron sheet, drying racks excluding concrete, clothesline poles, pipes), and dispose at designated collection points.
- One item for one Bulky Garbage Sticker (weight-wise, around 30kilogram per item).
- For items larger than 150x80x60cm, directly contact a licensed Disposal Company authorized by the City for collection. Door-to-door collection will be done by a licensed Disposal Company and you will be charged a separate collection fee.

#### E. Rubbles / Debris (Ceramics) / 10 Tiles, Concrete Fragments, Ceramics)

- Before disposing, write the name of your Neighborhood Association (or address, etc.) and your Full Name on the Designated Rubble Collection Ticket, attach the ticket, then place the bundle in a semi-transparent plastic bag (There are no designated Trash Bag for these wastes). As a guideline, please make sure that each item weighs approximately 10 kg.
- Please do not use rice bags (sacks) or cardboard boxes as the contents cannot be seen.
- For large amount of debris, you may transport it directly to the Yamanoue Debris disposal site. In this case, you must apply in advance at the Environment Division or thru the City Hall's branch office.
- When transporting directly to the disposal site, the first 300 kg of debris is free of charge (but a ¥300 per 100kg fee will be charged thereafter).

## F. Special Garbage (1)Used Battery (Alkali & Manganese Batteries Only), Button or Coin Batteries / (2)Fluorescent Lamp • Analog Thermometer (containing Mercury) )

- Dispose directly at designated collection boxes located at the City Hall or Branch Offices.
- Rechargeable Batteries & Button or Coin Batteries with a Recycle Mark may short-circuit, so please cover the metal terminals using an insulation tape, etc. Rechargeable Batteries with the Recycle Mark can also be collected in recycling boxes located at electronics stores.
- Dispose light bulbs under the Non-Burnable Glassware category.
- Dispose LED (Light Emitting Diode) Bulbs under Non-Burnable category.
  - (8) Items eligible for Home Appliance Recycling

G. Small, Used Electrical Items ( IW ireless phones (including smartphones), USB memory, digital

cameras, video cameras, electronic thermometers, etc.)

• Dispose directly at designated collection boxes located at the City Hall or Branch Offices. (Small appliances that can fit into the collection box's opening (height, 15cm × width, 31cm)

H. Recyclable Electrical Appliances ( ITV, Refrigerator, Freezer, Washing Machine, Air Conditioner, Clothes Dryer)

• Do not bring items (eligible for Home Appliance Recycling) under this Category to the garbage collection point.

I. Specific Garbage (15) Stone Mortar, Fiber-Reinforced Plastic items (Automobile, Motorbike, Bathtub) )

• Specific Garbage Category items cannot be brought to the garbage collection point. Directly contact a licensed Disposal Company (authorized by the City) for collection.

J. Items that cannot be Disposed at Garbage Collection Points)

• The items listed below <u>cannot</u> be disposed at the *Sasayuri Clean Park* Common Waste Disposal Facility. For proper disposal, consult with any of the following: Retailer / Dealer, the shop where you purchased the item, companies with expertise on the disposal of these items or contact a Licensed Disposal Company (authorized by the City).

Motors, engines, two-wheel motor vehicles, motorized bicycles, electric bicycles, auto parts (handles, bumpers, etc.), tires, wheels, batteries, fire extinguishers, drums, propane gas cylinders, steel ingots, manhole covers, piano wire, wire ropes, agricultural chemicals, agricultural machinery, containers of chemicals, potentially explosive items, etc.
