# 2 School Expenses Support (After Enrollment)



#### 1 What is School Expenses Support

To ensure children receive adequate education, Minokamo City offers financial support to households having financial difficulties in enrolling their child to Elementary or Junior High Schools in the city. This subsidy covers a portion of the school expenses.

Expenses Partially Covered: School supplies, fieldtrip expenses, extracurricular activity, exemption of school lunch fee, and others. XYou may also be eligible for other support system if you get approved to receive this subsidy.

### 2 Who are Eligible?

Those who meet all conditions below are eligible to apply.

- (1) Parents or guardians enrolling their child in Elementary or Junior High school in the city.
- (2) Households certified to have met the criteria for the city's school expenses subsidy or households receiving Public Assistance (Seikatsu Hogo)

※The criteria is the same as in number 2 (3) written in page 1.

However, due to income requirements, approval will depend on the Total Income Amount for the year 2025 (after the Board of Education's separate determination of Income Deduction amount).

#### 3 Flow from Application to Payment of Subsidy

• Distribution of Application Forms:

You may ask for the forms from your respective schools, the Minokamo City Board of Education General Affairs Division, or you can download from Minokamo City's Homepage

- Submission Place of the Application Forms:
- At your respective schools or at Minokamo City Board of Education General Affairs Division
- Application Period:

Any time after entering Elementary school

• Subsidy Payment Period:

The payment period will start on the 1st day of the following month of the day the school or the board of education has received the application and required documents **\*Application** for upcoming elementary 1st graders will only be acknowledged to start from April 1 if submitted within the month of April. This subsidy expires on March 31 every year.

• Subsidy Payment Date:

July 31, December 10, March 10, (All are schedules)

#### Note

Application for School Expenses Subsidy is required every fiscal year.

The application period for other students (2nd grade and above) is on January 2026.

# ① School Supply Subsidy for Newly Enrolled Students



#### 1 What is the School Supply Subsidy for Newly Enrolled Students?

As part of the School Expenses Support System, the School Supply Subsidy for Newly Enrolled Students Program subsidies a portion of the expenses to be incurred for the purchase of the necessary school supplies prior to entering Elementary school. This subsidy will be provided before the start of the school year.

Subsidy Amount: ¥57,060 (Upcoming elementary 1<sup>st</sup> graders)

Subsidy Payment Date: mid-December (Schedule)

Subsidy Payment Method: The bank account designated by the parent/guardian.

# 2 Eligible Applicants for the School Supply Subsidy

Those who meet all conditions below are eligible to apply

- (1) Parents/guardians of students living in Minokamo City.
- (2) Parents/guardians of children who are about to enter elementary school in Minokamo City
- (3) Households who meets the criteria of Minokamo City's certification standards (Criteria is as written in 1 and 2)
- Those who meet one of the criteria below. (Including all members of the household live together or those who have share in expenses.)

- 2. Final Income Tax Declaration Form FY 2024 (Copy)
- 4. Residence Tax Certificate for FY 2025

#### 3 Flow of Application

For those who wish to receive subsidies, please follow the procedure below. Documents to submit:

- School Expenses Subsidy (School Supply Subsidy for Newly Enrolled Students)

- 3 Attach required documents depending on the specified situation / reason.

\*You can get the form ① and ② from Minokamo City Board of Education, any elementary schools within the city, or download it from Minokamo City's Homepage.

Documents to be attached: The needed documents depending on the specified reason. Application Period: October 1, 2025 to October 31, 2025

How to submit: please submit them directly to the Minokamo City Board of Education General Affairs Education Division (submission via post mail is not accepted)

(Note)

- If you changed your address AFTER applying, please immediately inform the Board of Education
- Even if were eligible at time of the application, you will not be able to receive the allowance once you lose your eligibility before the day of the payment.

#### 4 Subsidies After Enrollment

# Application for $\underline{\text{other}}$ School Expenses Subsidy (school supplies etc.) after enrollment is required

Even if you have already applied for the School Supply Subsidy, submission of a <u>new application will be required on April 2026 (Refer to Page 3 for details)</u>

- For those who <u>received</u> the School Supply Subsidy:

  School supply fees etc., will be covered therefore you are required to apply again. . However, you will not be eligible to apply for the School Supply Subsidy for Newly Enrolled Students/School Supply Purchase Allowance after enrollment.
- For those who <u>did not receive</u> the School Supply Subsidy:

  If your application for School Expenses Subsidy have been application.

If your application for School Expenses Subsidy have been approved in April after entering the school, the payment for your School Supply Subsidy for Newly Enrolled Students/School Supply Purchase Allowance will be made in July
