Usage Guidelines for FY 2024 After-school Children's Club (*Hokago Jido Club*) (令和6年度美濃加茂市放課後児童クラブ利用要項)

The acceptance of applications for FY 2024 After-school Children's Club (Hokago Jido Club) will start.

The After-school Children's Club is a service covering elementary school students within the city, whose parents or guardians (including grandparents) are not home after school hours because of work, etc.

The club is a substitute place where students can stay after school instead of going home and is operated separately from the school. For those who wish to use this service, please submit the necessary documents.

The part of this guide with '_____' is scheduled for implementation by April 1, 2024 but is subject to change.

1. Criteria for Eligible Students (利用できる児童の要件)

- Elementary school students from 1st to 6th grade.
- Children whose parents or guardians (%1), due to one of the reasons listed below, need to use the service for more than 15 days a month or more than 3 days a week; and who are unable to look after their children (%3) during day time (until 4:00PM %2) whose children will use the facility for 3 or more days per week.

Reason for Use:

Employment, etc.	Parents or guardians who are working outside of the house, attending school, or undergoing technical training during the daytime	
Pregnancy / Childbirth	From the <u>first day of the month</u> that covers the 6th week before childbirth to the <u>last</u> <u>day of the month</u> that covers the day after the 8th week from childbirth.	
Illness / Injury	Parents or guardians who are hospitalized or undergoing hospital care as an outpatient	
Caregiving / Nursing	Parents or guardians who are looking after / nursing another family member at home or at a separate home	
Job Hunting	Single mother (or father) who is currently in the process of finding a job	

%1 Parents, grandparents, siblings 20 years old above & even relatives who live with the household members (individuals not included in the same legal household but are currently living together are also included).

★2 Due to any one of the reasons written above that ends at 4:00PM or later (not including time for commute). However, those intending to use the service during Spring, Summer, and Winter Vacations only, commitments ending after 12:00PM are eligible.

X3 For those requiring protective care so the child could have a place to stay safely (at home, etc.).

* Students may be denied usage of the club if the Board of Education deems that the club will not be able to give proper childcare due to management issues, life guidance disabilities, physical weakness, etc.

* If there are relatives (such as a grandparent, etc.) living nearby, please submit their Employment Certificate(s).

2. Location and Capacity (開設場所と定員)

(1) The club is scheduled to be held at elementary schools and at Kamono Children's Center (*Kamono Jidokan*). The capacity is as follows.

*The opening of Kobi *Shogakko 2nd Hokago Jido Club* will be determined depending on the number of applicants for the Kobi *Shogakko 1st Hokago Jido Club*.

- *For the Kamono district, admission will be divided between Kamono *Shogakko Hokago Jido Club* and *Jidokan Hokago Jido Club* to equalize the number of children in these clubs.
- %If we receive requests that exceed the capacity, we will expand the capacity to another room.
- (2) Miwa *Shogakko Hokago Jido Club* will be held jointly with Ibuka *Shogakko Hokago Jido Club* at X Ibuka Elementary School.
- (3) On Saturdays, children of all clubs will be looked after in one location only: Yamate *Shogakko Hokago Jido Club*. (Drop off and pick up must be done by their parents or guardians.)

- Fees will be charged regardless of attendance. <u>Therefore, if the child enters or leaves the school in the</u> <u>middle of the month, the childcare fee will be calculated on a daily basis as stipulated by Article 11 of the</u> <u>Minokamo City Ordinance on the Implementation of After-school Children's Health Development Program.</u> Once paid, the childcare fee will not be refunded.
- (2) <u>Households facing difficulty paying childcare fees due to reasons of natural disasters or others may have their</u> <u>childcare fees reduced or waived. Example: Households receiving Public Assistance (*seikatsu hogo*), households <u>eligible for Partial-Protection School Tuition Assistance, and households exempt from resident tax</u> must apply using the "Childcare Fee Reduction / Exemption Application Form." (Application is required every year.)</u>
- (3) The payment will be charged using automatic bank transfers (*kouza furikae*). After receiving the "Acceptance Form" please submit the "Minokamo City Automatic Bank Transfer Application Form" to your bank / financial institution (the application form is available in every financial institution within the city). Bank transfer date is scheduled at the end of every month, so please make sure that your account has sufficient balance. (※ If the end of the month is a holiday, the transfer date will be on the next business day.) For those who are planning to sign up for any Plan from ③ through ⑥, the bank transfer date is scheduled on the last day of August.
- (4) Those with pending unpaid fees at the club will be ineligible to use the club. In addition, <u>3 months' worth of delayed payments will result in the revocation of eligibility.</u>
 **By April 1, 2024, a new ordinance partially revising the Minokamo City After-school Child Health Development Program is scheduled to come into force.
- (5) If you want to change your class category plan or quit the club, please make sure to submit the "Application of Changing of Class Category Plan" or "Notification of Cancellation" form by the 20th of the month prior to the month you wish to change the plan or quit the club.

4. Operating Hours, Holidays (開設する時間、休業日)

- (1) School days : From the end of school classes until 6:30 PM \downarrow <u>Please be punctual!</u>
- (2) Holidays : From 7:30 AM to 6:30 PM

X If you fail to pick your child up on time, your eligibility will be revoked.

- (3) The club is not open during Sundays, National Holidays, Obon Holiday (August 13 to August 15) or the Year End Holiday (December 29 to January 3). Furthermore, the club is not open on the day before the start of Summer Vacation, the last day of Summer Vacation, and during the end of the Fiscal Year (end of March).
 (4) There may be down when the club will not be switched as a club will not be summer vacation.
- (4) There may be days when the club will not be available due to other circumstances.
- 5. Acceptance Period, Documents to Submit and Place of Submission, etc. (受付期間、提出書類、提出場所等)

• Those who chose **Plan** ① or ② "Whole-Year", circle [yes or no] to show your intent to use the Club during the summer vacation. (No fees for August will be paid if you will not use the Club during summer vacation).

• You have to re-apply even if you are using the Club in the current FY 2023 or have used it in the past. There is no Auto-renewal in this service.

(2) Certificate of Employment, etc.

- Certificates of Employment of all family members, such as parents, grandparents, etc. (except minors) who live together with the child, are needed. In case of multiple applications (for siblings), you can attach a copy of the original certificate to other children's applications.
- If you have submitted the documents for Nursery School procedures within 3 months, you may not need to submit them again.

(3) "Checklist: Things to Consider" (Parent's copy)

- Please read carefully and keep the copy in a safe place in the duration of *Hokago Jido Club* attendance.
- (4) Minokamo City Automatic Bank Transfer Application Form (after Approval) **Make sure to accomplish!
 Please do the procedure at a financial institution within the city. (Application form is available in every
 - financial institution within the city).
 - Write the parent's name in the "taxpayer" column of Hokago Jido Club Application Form.
 - You do not have to do this procedure if you have used the club in the past and have already submitted this.

6. Notice of Approval (入室の決定通知)

• We will inform you by sending a Notice of Approval for Hokago Jido Club by mail in early March.

7. Reminders(注意していただくこと)

- 1. If you have remaining unpaid fees, you will not be eligible to use the club. Furthermore, **3 months' worth of delayed payments will lead to the cancellation of your permit to use the service.**
- 2. Due to business hours, parents or guardians must pick up their child by 6:30 PM. If you repeatedly fail to pick up your child on time, you will be asked to withdraw from using the Club. You may be refused admission, if it is established based on previous records, that you had cases of not properly using the Club.
- 3. After checking the documents that you submitted, the Board of Education will decide whether you can use the service or not. If you have provided false information in your application or insufficient documents, you will not be able to use the service.
- 4. If the number of applicants exceeds the limit during the Application period, elementary students from 1st to 3rd grade will be prioritized to use the Club. In such cases, please understand that you may be placed on the 'Waiting List'. Also, applications will still be accepted even after the acceptance period, but please keep in mind that you will be placed on the 'Waiting List' if the capacity has been reached. %If placed on 'Waiting List', we will inform you as soon as slots becomes available.
- 5. If you become ineligible based on the criteria for using the club, you cannot continue using the service. Please submit the form "Application for Change of Class Category Plan" or "Notification of Cancellation" until the 20th of the month prior to the month when the implementation of service will start.
- 6. Please keep in mind that there are rules and regulations for group activities inside the club. If inconsiderate behaviors that disturb such activities continue, the staff will not be able to watch over other students safely. If the *Hokago Jido Club* decides, with approval from the Board of Education, that a student **is not following the rules** he/she will not be able to continue using the club.
- 7. Notice regarding suspension or resumption of Club operations due to safety alerts will be posted on Minokamo City's website.

8. Insurance Membership(保険の加入)

• The child will have an accident insurance while they are enrolled in the club.

9. Online Application (Available in Japanese Language only)

• You can apply directly via the Minokamo City's website or by scanning the 2D-code using


