## Guide on the Application for the FY 2026 School Expenses Support

### 令和 8 年度(就学援助費の申請について)

The “School Expenses Support” is a system that provides support for school supplies, school lunch fee, and other school expenses to children having difficulty attending public elementary and junior high school due to reasons related to their household’s financial conditions.

For those who wish to apply for “School Expenses Support” please submit the application form after attaching the required documents according to the following procedure. If you are receiving support this fiscal year and would like to receive continued assistance the next fiscal year (2026), please make sure to re-apply.

#### 1 Eligibility for this Program

Those who meet all of the following conditions are eligible.

- Parents of children and students whose address is registered in Minokamo City and are enrolled in a municipal elementary or junior high school. (For school expenses support of children attending Futaba Junior High School, please consult with the Tomika-cho Board of Education.)
- Households that meet one of the recognition standards for school expenses support in Minokamo City. (Recognition standards are as follows:)

Reason for Application	Documents to Prove the Reason for Applying (Photocopy is acceptable)
① Receiving Livelihood Assistance ( <i>seikatsu hogo</i> )	Not required
② Receiving Child-Rearing Allowance	Child-Rearing Allowance Recipient Certificate
③ Suspended/Cancelled Public Assistance (during FY2024 or FY2025)	Not required
④ Tax exempted or receiving tax reduction (all household members)	Municipal /Prefectural Income Tax Certificate (for FY 2026) (※1)
⑤ Receiving tax reduction on Business/Property Tax	Notice of Tax Reduction
⑥ Reduction of National Pension Premiums or reduction / postponement of payment of National Health Insurance Premium (all household members)	Notice of reduction / postponement of payment.
⑦ Financial difficulties, guardian’s sickness, death, loss of work, applying for Child Rearing Allowance and other particular circumstances. ** However, debt payments such as Housing loans cannot be considered.	Documentary Proof of Income for the Year 2025 (Reiwa 7) (see below) *If you are receiving Public Pension (Survivor's Pension, Disability Pension, etc.) or unemployment benefits, provide documents that show the amount you are receiving.

(※1) Applications for reason stated in ④ above cannot be made before mid-June 2026 as Municipal Tax Certificates issued by the City Hall will only be released from around then (mid-June 2026).

\*\* If these guidelines are revised, the acceptable reasons for application / eligibility for payment may change.

Family Composition (Age)	Household Income
2 people Mother (39) Child (5 ・ preschool)	Approx. ¥ 2.06 M
3 people Father (39) Mother (39) Child (7)	Approx. ¥ 2.77 M
4 People Father (39) Mother (39) Child (14) Child (4)	Approx. ¥ 3.26 M

This may vary slightly depending on the family structure and age.

#### ※Documents that proves your income during FY 2025:

Any of the following (Photocopy is acceptable)

Regardless of income, this is required for all household members.  
However, this is not required for those between the ages of 16 and 18 who have no income.

- Year 2025(R7) Withholding tax slip (*gensenchosu hyo*)
- Year 2025(R7) Final Income Tax Returns Form (*kakutei shinkoku*) (Copy)
- Municipal/Prefectural Tax Declaration Form for Year 2026(R8) (Copy)
- Municipal /Prefectural Income Tax Certificate for Year 2026(R8) (※June, 2026~)

## 2 Documents to be Submitted

1. The School Expenses Support Application Form for year 2026 (One application form is required for each child)  
※ Application form is available at each respective Elementary/Junior High Schools and at the Board of Education
2. Documents that can verify the reason for application (Photocopy is acceptable / see the reference)

### **【For those who will be enrolled in Futaba Junior High School in the next School Year】**

The *Tomika-cho* Board of Education will provide support for children attending Futaba Junior High School.

## 3 Place of Submission

Please submit the above documents (1) and (2) to each respective Elementary/Junior High School or at the Educational Affairs Division.

## 4 Application Period

### (1) Enrolled Student

(Students who will be 2<sup>nd</sup> grade year Elementary students to 3<sup>rd</sup> year Junior High School students)

**Application must be submitted between Jan. 5 (Mon) to Jan. 30, 2026 (Fri)**

Even those approved for the current year are also required to apply yearly!

**【For those who will file Final Tax Return】**

The following deadline is for households with members that settles their income amount by filling income tax return (**Self-employed, etc.**). As for those who are scheduled to file their Tax Return later than this date, please contact the Board of Education directly.

**The application deadline for households who have Final Tax Returns is: Feb 27 (Fri).**

### (2) For incoming 1<sup>st</sup> grade Elementary School students: **Application must be submitted between Apr. 1 (Wed.) to Apr. 30, 2026 (Thu)**

※ Applications will still be accepted at any time (even outside of the application period). However, if approved, it shall take effect on the 1<sup>st</sup> day of the succeeding month from the date of Application.

※School Supplies and School Supply Cost Newly enrolled (Students) will not be given to those who have already received a School Supplies and other Preparation Cost for newly enrolled students.

※School Supplies Cost for newly enrolled students will only be given if it was certified at the beginning of the fiscal year.

※The amount indicated above is the total for 1 year. Payment will be divided into 3 payments on July, December and March.

## 6 Reminder

### ○ **The School Support System does not exempt school collection fee.**

School Collection Fee refers to expenses related to school attendance, such as extracurricular activities, which are collected by the school principal. Please make sure to provide for and pay these fees.
